



Oakridge Primary School Governing Body (meet all IOG requirements)

Ratified at Full Governors October 11th 2021

1. The governing body shall consist of:
 - a. 3 parent governors
 - b. 1 local authority governor
 - c. 1 staff governor
 - d. 1 Head teacher governor*
 - e. 5 co-opted governors
 2. Total number of governors is 11*except at any time when the Head teacher has given notice that she/he chooses not to be a governor, when the total number of governors shall be 10.
 3. The term of office for co-opted governors is 2 years.
 4. This instrument of government comes into effect on 21st October 2019. This instrument was made by order of Staffordshire County Council Local Authority on 1st November 2019.
 5. The school is a community school.
 6. The name of the governing body is 'The governing body of Oakridge Primary School, Stafford.'
- A copy of the instrument must be supplied to every member of the governing body (and the head teacher if not a governor), any trustees and to the appropriate religious body.
