



**Oakridge Primary School**  
**Governing Body (Meet all IOG requirements)**

Ratified at Full Governors October 12<sup>th</sup> 2020

1. The governing body shall consist of:
    - a. 3 parent governors
    - b. 1 local authority governor
    - c. 1 staff governor
    - d. 1 Head teacher governor\*
    - e. 5 co-opted governors
  2. Total number of governors is 11\*except at any time when the Head teacher has given notice that she/he chooses not to be a governor, when the total number of governors shall be 10.
  3. The term of office for co-opted governors is 2 years.
  4. This instrument of government comes into effect on 21<sup>st</sup> October 2019. This instrument was made by order of Staffordshire County Council Local Authority on 1st November 2019.
  5. The school is a community school.
  6. The name of the governing body is 'The governing body of Oakridge Primary School, Stafford.'
- A copy of the instrument must be supplied to every member of the governing body (and the head teacher if not a governor), any trustees and to the appropriate religious body.
